
- The Commissioners are encouraged to review all map plans that have been submitted for the week, as some submitters may decline to present.

Map Submittal Update – COD-013 Betzen


- Max Dev 9.46%

- Hispanic 5 (1,5,6,7,9)
- Districts 10 has low compactness scores
- # of neighborhood associations split – 51 out of 443

- Max Dev 1.68%
- # of Minority Districts 9
- NH-Black 3 (3,11,12)
- Hispanic 6
 (4, 6, 9, 10, 13, 14)
- # of neighborhood associations split – 26 out of 443




Map Submittal Update – COD-015-Betzen


