Chairman Oliver, Vice-Chair Ragsdale and Commissioner Neerman,

I am a resident of District 12 (Address). As a concerned resident and voter, I ask you to consider placing the new district 12 line along Preston Ridge Trail instead of Campbell Road.

If the new District 12 line is placed on Campbell Road, two different HOAs will be separated (Campbell Green HOA and Highlands North HOA). We depend on our HOA to disseminate important neighborhood matters, city council updates and much more. I can't imagine the chaos and confusion this would cause. Additionally, Campbell Green Recreation Center is an important part of our neighborhood and sits right on Campbell Road.

If the new District 12 boundary line is placed along Preston Ridge Trail, Campbell Green HOA and Highlands North HOA will stay together. Please do not use Campell as the new district 12 line. Please do not separate our HOAs and please keep Campbell Green Recreation Center in District 12 with the entire Campbell Green HOA.

Please keep the geographic integrity of Campbell Green and Highlands North neighborhoods by NOT placing the new redistricting line along Campbell.
