## 1. Public Speakers

• The Redistricting Commission had 13 public speakers for their April 4, 2022 Redistricting Commission Regular Meeting.

- 2. Approval of March 28, 2022 Minutes
  - The minutes from the March 28, 2022 Redistricting Commission Regular Meeting were approved by the commission.
- 3. BRIEFING ITEM: Map Submittal Update
  - ARCBridge Consultants provided an update on the total number of maps submitted to-date related to the redistricting process and the criteria they use in reviewing map submissions.
  - General questions related to map submissions were asked by the Commission and answered by ARCBridge.
- 4. ACTION ITEM: Map Selection Process & Calendar Discussion
  - Chair Jesse Oliver provided a brief introduction on the outline of the next phase of the Map Selection Process.
  - The Commission discussed generally the outlined dates and meeting plans for the remainder of the Commission's timeline before the floor was opened for motions regarding the process and calendar.
  - Commissioner Gregory Demus made a motion to move the map submission deadline to April 30, 2022.
    - The Commission held general discussion on the motion.
    - After a vote, the motion failed to pass.
  - Commissioner Robert Stimson made a motion to adopt the process and calendar as proposed.
    - The Commission held general discussion on the motion.
    - The motion failed due to the lack of a second.
  - Commission Domingo Garcia made a motion to change the time of the May 7, 2022 Public Hearing to begin at 3:00 p.m.
    - The Commission held general discussion on the motion.
    - After a vote, the motion passed.
  - Commissioner Randall Bryant made a motion to move Phase 1 and Phase 2 of the the map selection process to April 25, 2022; to move Phase 3 of the map selection process to May 2, 2022; to eliminate the May 5, 2022 proposed meeting date; and to keep the remaining dates the process the same.
    - The Commission held general discussion on the motion.
    - After a vote, the motion passed.
  - Commissioner Norma Minnis made a motion to strike all language from the proposed process that referenced census blocks.
    - The Commission held general discussion on the motion,
    - After a vote, the motion passed.
  - Commissioner Randall Bryant made a motion to amend the language regarding a commissioner's proposed amendments to the final maps. The newly proposed language would require a proposed amendment to be withdrawn if that amendment

were to unbalance the map and result in the map no longer meeting the required criteria.

- The Commission held general discussion on the motion.
- After a vote, the motion passed.
- Commissioner Brent Rosenthal made a motion to adopt the process and calendar as amended.
  - The Commission held general discussion on the motion.
  - After a vote, the motion passed.
