I am a resident of District 12 ([REDACTED] - 75248). As a concerned resident and voter, I ask you to consider placing the new District 12 boundary along Preston Ridge Trail instead of Campbell Road.

If the new District 12 boundary is along Campbell Road, that would place 3 recreation centers (Campbell Green, Fretz, & Churchill) in District 11, leaving only 1 (Timberglenn) in District 12. That would imbalance resources and negatively affect our neighborhood resources.
